Broken Heart Syndrome

Doris Vaughans, LPC, PhD, LPC, NCC



Doris Vaughans

This session will explore the Broken Heart Syndrome, its diagnostic complexities, its implications for hospice care, and the ethical and clinical considerations involved in supporting patients, caregivers, and bereaved individuals at elevated risk.

Dr. Vaughans will describe the clinical features and contributing factors associated with the Broken Heart Syndrome and discuss the relationship between emotional stressors and the physiological responses that characterize the syndrome. Participants will be able to identify possible risk factors that increase vulnerability among hospice patients, caregivers and bereaved individuals.

About Doris

Dr. Doris Vaughans has a private practice, Tuscaloosa Center for Cognitive Therapy. She is an international faculty member at Portland Institute for Loss and Transition, the Associate Director of Embedded Counseling at the University of Alabama, and teaches grief counseling at the University of West Alabama as an adjunct professor. Since the death of her beloved son, CJ Vaughans, she has been educating the public on Broken Heart Syndrome.

Dr. Vaughans had a career as a Registered Nurse for more than 22 years in the areas of palliative and hospice care. Dr. Vaughans is the mother of three children, Tiffany, CJ (1985 - 2025), and Lea. She is a member of Delta Sigma Theta Sorority, Inc, Tuscaloosa Alumnae Chapter, Bethel Missionary Baptist Church, and loves reading, watching football, traveling, all things grandchildren, and spending time with family and friends.

The founding idea of Hospice

- The modern hospice movement began in 1967 with St. Christopher's Hospice in London, founded by Dame Cicely Saunders.
- This was the first place designed specifically for people who were dying, not to cure them—but to care for them.
- Hospice in the late 1960s focused on a radically different philosophy:
 - Relief of pain (what Saunders called “total pain”)
 - Emotional and psychological support
 - Spiritual care and dignity at end of life
- This “whole-person” approach was groundbreaking compared to traditional medical models.

With over eighteen years of experience in hospice and seven years in emergency medicine, Lisa helps individuals and families navigate illness, dying, and grief with greater clarity and compassion.

She is also an expert contributor for Help Texts, providing grief and mental health support through text-based care, and volunteers with the Humane Prison Hospice Project, supporting palliative care education for incarcerated individuals. Guided by her belief that peace at the end begins with meaningful conversations over time, Lisa engages audiences in thoughtful, approachable dialogue that encourages preparation, connection, and a deeper understanding of what it means to live and die well.

By the early 1970s, hospice ideas spread to the U.S. and elsewhere.

- The first modern U.S. hospice (Connecticut Hospice) was established in 1974, inspired by Saunders' work.
- Hospice was not widely known—many people (even healthcare professionals) didn't understand it.
- Programs were often small, community based or volunteer.

Hospice in the 1970s often looked like:

- Home-based care (many patients stayed with family)
- Volunteer support teams (nurses, clergy, social workers, and trained volunteers)
- Limited or no insurance reimbursement
- Reliance on donations and community support

Hospice was defined by its focus on comfort, support for patients and families and acceptance of death as a natural part of life.

Peace, Love, & Pain, Symptom Management

Jackie Palmore, RN, BSN, CHPN



Jackie Palmore

In this presentation, Jackie's goal is to empower attendees with advanced clinical knowledge and practical strategies to confidently assess, manage and optimize pain control, ultimately improving the quality of life and comfort for patients at the end of life.

By the end of the presentation, participants will be able to identify the components of total pain (physical, psychological, social and spiritual) and evaluate how each impacts a patient's overall comfort. They will also be able to formulate an individualized multi-modal pain management strategy utilizing both pharmacological and non-pharmacological interventions.

About Jackie

Jackie Palmore has 37 years combined experience in hospice and palliative care. An exciting part of her nursing career was the opportunity to implement the first hospice prison program for the State of Alabama in 2001, training volunteer inmates to care for dying inmates. She is passionate about education when it comes to hospice and palliative care. She is an End-of-Life Nurse Educator and has an advanced certification in hospice and palliative care.

She has been with UAB's Center for Palliative and Supportive care for 20 years in her role as a Palliative Care Coordinator.

By the end of the 1990s, hospice in the U.S. had evolved from a small, philanthropic experiment into a permanent Medicare benefit

- Medicare Hospice Benefit (1982) — The single most important milestone. Congress created a demonstration benefit that allowed Medicare to reimburse hospice care, legitimizing the model and enabling growth.
- National Hospice Organization (NHO) standard-setting (1978-1985) — The NHO published common standards of practice, paving the way for accreditation and quality control.
- Joint Commission accreditation (early 1980s) — Helped formalize hospice as a healthcare provider rather than a volunteer service.
- Shift from volunteerism to professionalization — Early hospices relied heavily on volunteers and philanthropy; the 1980s introduced interdisciplinary teams, clinical protocols, and regulatory expectations.
- Federal research investment — The National Cancer Institute funded early hospice research, validating the model and informing policy.

What this decade accomplished: Hospice became a recognized, reimbursable, regulated part of the U.S. healthcare system.

 Gabby Jimenez  Gabby Jimenez	There is a deeper meaning behind the and language and experiences that shape end-of-life care. Gabby strives to reconnect participants to the heart of hospice work by reflecting on relational aspects of care, presence, listening and honoring individual choices. Her goal is to cultivate a renewed sense of purpose, meaning and pride in the work of accompanying others at the end-of-life About Gabby Gabrielle Elise “Gabby” Jimenez is an end-of-life educator, author, hospice nurse, and founder of The Hospice Heart, an online community offering support and education around death, caregiving, and grief. She entered this work at 45 after helping a close friend with prostate cancer. Sitting at his bedside showed her the power of compassionate presence, inspiring her to complete an adult-education program, become a caregiver, and later train as a hospice nurse. In 2019, she launched The Hospice Heart on Facebook as a safe space for end-of-life conversations. The community grew rapidly—especially during COVID-19—and now includes more than 140,000 people who are dying, caregiving, grieving, or preparing for loss.

Alone, Not Unprepared: Protecting Hospice Staff in the Office and the Field - Edward Colson

The goals of this program is to identify common workplace violence risks specific to hospice settings, including both office environments and in-home patient visits, and recognize early warning signs staff should not ignore.

Participants will be able to apply practical strategies to reduce risk and improve staff safety, including pre-visit planning, situational awareness, communication protocols, and clear decision-making in the moment.

He has worked in emergency management since 2016, assisting healthcare partners with emergency management and preparedness needs, including planning, training, and exercises. 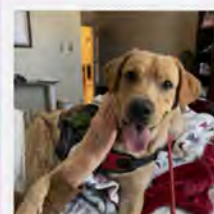

About Rodney Rodney O. Tucker, MD MMM, graduated from medical school at UAB in 1989 and is board certified in Internal Medicine and Hospice and Palliative Medicine. After a career in private practice, home care and hospice, Dr. Tucker returned to UAB in 2002. Since then, he has been active in the development of a comprehensive clinical, educational and research program in palliative care, including the Southeast Institute for Innovation in Palliative and Supportive Care at UAB. Serving currently as the Director of the UAB Center for Palliative and Supportive Care, Dr. Tucker also completed his Masters in Medical Management at the University of Southern California in 2009. He has been a member of the American Academy of Hospice and Palliative Medicine (AAHPM) and the Center for the Advancement of Palliative Care (CAPC) for two decades, having served in several leadership roles. He was the national President of AAHPM in 2020-2021 and has participated in the education and mentorship of over 300 fellow learners and health care systems. Hospice in the 2000s: Regulation, Scale, and Complexity

- Increased regulation and compliance oversight
- Rise of for-profit hospice organizations
- Broader patient eligibility (more chronic illness, not just cancer)
- Growing scrutiny on billing and quality
- Oversight organizations like OIG and CMS intensified focus on:
 - Fraud prevention
 - Billing accuracy
 - Eligibility requirements
 - Audits, investigations, and payment reviews became more common
